
1) Agreement

This is an agreement between you, the purchaser and licensee and Mirco Schiavone. This End User License Agreement (EULA) becomes binding by purchasing, downloading, installing, using or in any form handling the typeface software (hereafter fonts). By in any way mentioned above handling the fonts provided by Mirco Schiavone you accept the terms of this agreement and acknowledge understanding and complying with its terms.

2) Licenses

By purchasing a license you are not purchasing the copyright or any other part of the fonts, but only the limited rights to use fonts under terms and conditions defined in this End User License Agreement. The purchased license is for a single user only. The font shall be installed on a maximum of one (1) portable device (laptop computer) and on one (1) non-portable device (desktop computer). Further licensing options for more devices within your organization are available on request. Within your organization means inside your company or organization and does not include usage by third parties. Multi-license users must be part of the same legal person (company, organization).

3) Embedding

You are allowed to embed copies of fonts only in your electronic documents for purposes of printing and use on private computer networks within your organization.

The purchased license is only a desktop license, delivered in OpenType format, and does not permit the embedding of fonts in electronic documents such as websites, PDF documents, Flash documents, electronic books, any software, any motion picture, and any computer application or mobile phone application. Special licenses for uses of fonts according to this paragraph 3) are available on request. You will not be authorised to convert Mirco Schiavone's fonts (directly or through third-party applications) into any other format than received.

4) Copying and modifying

You may make copies of the fonts for back-up purposes only. Any distribution of fonts or any component of the fonts to people outside of your organization is not allowed.

You may not modify, disassemble, decompile or make any changes to the fonts without first getting written permission by Mirco Schiavone. Any rights of the original version and the edited version remain with Mirco Schiavone, and the terms and conditions covered by the license remain the same for the original version and the edited version.

The fonts or any modified version of fonts may not be distributed, lent, sublicensed, rent, sold, given away or shared with other people or businesses. Mirco Schiavone does not offer support or guarantee the proper functioning of any modified versions of fonts.

5) Liability

If you encounter difficulties working with the fonts, we will do everything we can to resolve any issues. If, after we have worked with you to resolve any technical issues, you are still not satisfied with the product we will be pleased to refund your money, which shall be the limit of our liability in this transaction. Any such refund terminates your license to use the fonts, and you have to delete any copies of the fonts. Only technical issues are reason for refund, and you have to show clearly that they do exist and can not be resolved by Mirco Schiavone. You must give Mirco Schiavone notice of such problems in the first 30 days after your purchase. Under no circumstances shall Mirco Schiavone's liability exceed the substitution or the replacement cost of the fonts.

Mirco Schiavone shall in no event be liable for any direct, indirect, consequential, or incidental damages, arising out of the use or inability to use the fonts.

6) Breaches

Any breach of the terms and conditions specified in this agreement terminates your license automatically. You must delete all copies of the fonts and certify to Mirco Schiavone that no fonts remain in your possession.

7) All Rights

Any rights not expressly granted in this agreement are reserved to Mirco Schiavone.

8) Governance

This agreement shall be governed by and construed in accordance with Swiss law. Place of performance is Zurich, Switzerland. The courts of Zurich, Switzerland shall have jurisdiction.

This Agreement contains the entire understanding between the parties and supersedes any prior understandings and agreements, oral or written.
